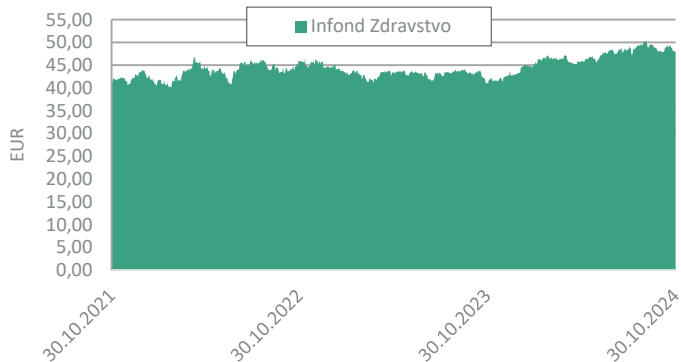


The risk indicator is based on the assumption that investor holds the fund for at least 5 years.

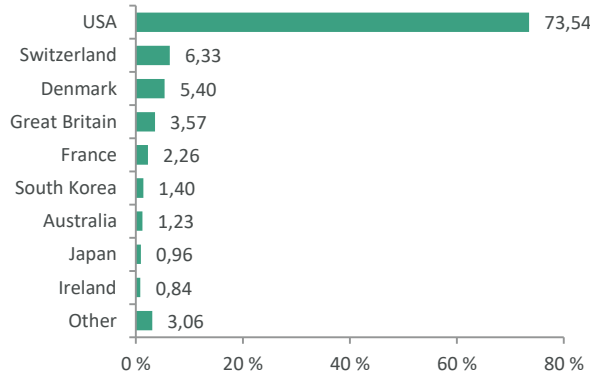

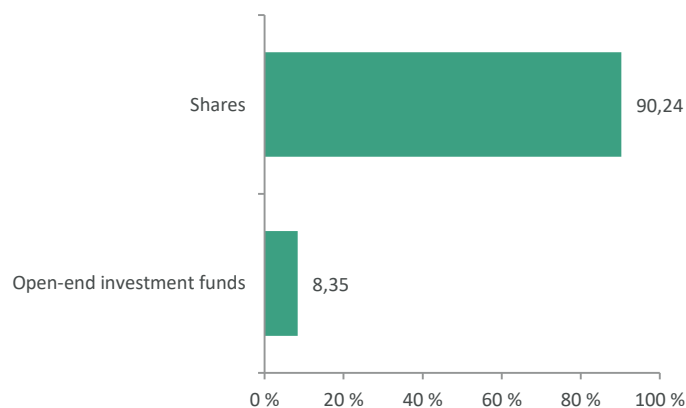
**Geographic allocation**



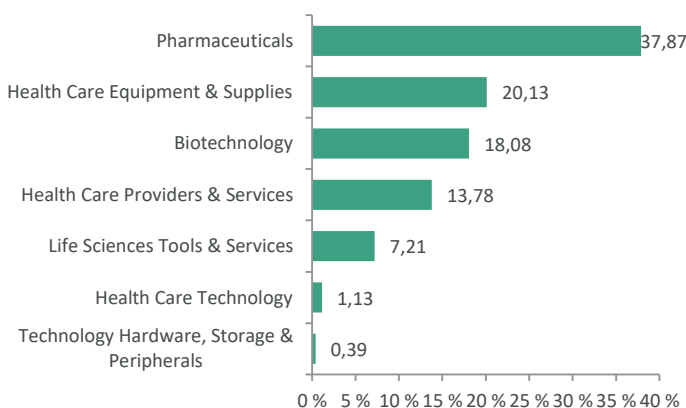
**Geographic allocation**
